



CUSTOMER VEHICLE DEMONSTRATION AGREEMENT

We the dealer, allow the Customer (as stated in the Authorised Driver Declaration) to take one of our vehicles on loan or for a test drive, subject to the following conditions;

CONDITIONS OF USE

1. The Vehicle will only be driven by the Customer. The Customer will ensure no other person will drive the Vehicle, without the express consent of the Dealer.
2. The Customer agrees to take reasonable care of the Vehicle and to take reasonable precautions to safeguard the Vehicle from loss or damage.
3. If the Vehicle is taken over night, the Customer must ensure the Vehicle is locked at all times when not being used, activates any alarm and immobiliser if installed in the Vehicle, and parks the vehicle on their private property.
4. The Customer confirms by signing this Agreement that their License is current and will not be in any breach of any condition of license by driving the Vehicle.
5. The Customer agrees not to smoke or carry any pets or goods while the Vehicle is in their care. In the event this condition is breached the Customer will be liable for any cleaning costs if necessarily incurred as a result of smoking, or carrying any pets or goods.
6. All Traffic Infringements, Parking Fines and the like while the Vehicle is in the Customers care, must be reported to the Dealer at the time the vehicle is returned to the Dealer and are payable entirely by the Customer.
7. The Customer is expressly prohibited from using the Vehicle to carry on any kind of business activity.
8. The Dealer reserves the right to charge for mileage, where there has been excessive and or unauthorised use of the Vehicle, including refilling the petrol tank and wear and tear which can be attributed to the additional use.
9. The Dealer reserves the right to charge for any part or accessory removed or lost from the Vehicle where in the opinion of the Dealer this has been caused by the Customer or the Customers lack of diligence in safeguarding the Vehicle.
10. The Dealer reserves the right to charge any wilful damage to the Vehicle either directly or indirectly by the Customer.
11. The Customer must at all times operate the Vehicle with traffic regulations and local laws. Any breach of these which, in turn, causes a breach of the Dealers insurance cover, which negates the Dealer being able to claim for loss or damage shall be at the Customers own cost.
12. In the event of loss or damage which the Dealer is able to claim from their insurance cover, the Customer shall be liable for the amount stated in the Authorised Driver Declaration being the Dealers Policy Excess.
